

According to the manufacturer's data, the base polymer meets the requirements of the paragraph under the conditions A throught H to FDA 21 CFR 176.170(c), table 2 and can be used with all type of food to table 1 of 21 CFR 176.170 (c).

There are requirements regarding extractive limitations as specified in FDA § 21 CFR 177.1520. Adherence to these requirements has not been tested on the compound since they are usually referring to the final article.

As to the manufacturer's data, the other additives meet the requirements for repeated contact with food according to FDA

§ 21 CFR 178.3297 (Colorants for polymers).
